Lister, Jr. and Patsy C. Lister and their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, near Pleasant Grove Baptist Church, lying on the south side of a new road that leads off of State Highway No. 14 at or near the Old Pleasant Grove Parsonage lot and into the new road that leads off of the said highway at or near the Pleasant Grove Church, being bounded on the north by the first named new road, on the east by lot conveyed by J. A. Wood in September, 1953, to J. T. and Charlotte Hamby, on the south and west by other lands of J. A. Wood, and being a part of the same tract of land shown as Tract No. 2 on plat of property of L. 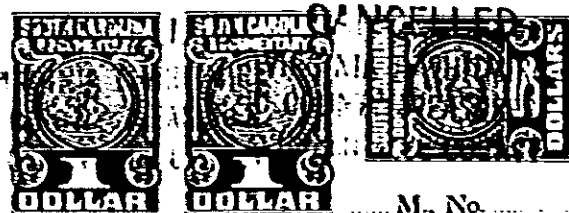
