REAL PROPERTY AGREEMENT

- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: Beginning at an iron pin on the west 88 side of Paris View Drive (formerly Fairview Ave.) the front joint corner of Lots 41 & 42; thence with the west side of said Paris View Dr., S.8-55 E 48.6 feet to a point; thence S 10-52 W 50 feet to a point; thence S. 33-52 W. 65 feet to a point; thence S 46-52 W 30.4 XXX feet to a point; thence S 78-42 W. 23.9 feet to an iron pin corner of the intersection of West Hillcrest Dr; thence with the north side of West Hillcrest Dr. N.49-28 W. 50 feet to a point; thence N 63-02W. 59.6 feet to an iron pin corner of Lot 44; thence with the line of said lot N 24-46 E 76.6 feet to an iron pin corner of Lot 41; thence with the line of said Lot N 71-21 E. 150 feet to the beginning corner.

Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of assigns, and inure to the benefit of Bank and its successors and assigns. Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
