



PETITION AND EASEMENT

We, the undersigned property owners along Guilder Creek in the County of Greenville, do hereby petition and request the County of Greenville or any other governmental agency to perform work in, along and adjacent to said Creek and its banks in order to improve the natural flow thereof and improve drainage and lessen the hazards of flooding. We do hereby agree for the County or any other governmental agency to make use of our land for such purpose and to bring the necessary machinery thereon and do hereby grant to the County of Greenville or any other governmental agency a temporary easement for working purposes along a strip thirty (30) feet wide on each side of said Creek. We agree that the banks of said Creek may be sloped and that all trees, growth, shrubs, and other obstructions that, in the opinion of the County Engineer, need to be removed may be removed. It is understood and agreed that Greenville County or any other governmental agency will not do any landscaping repairs and may leave such dirt and debris as it may remove from the Creek along the area for removal by the property owner. The undersigned do hereby release the County of Greenville or any other governmental agency, its officers, employees and agents from any and all liability for any damages incurred to property, lawns, trees, shrubbery, tile fields, septic tanks or any other property damage.
