All that piece, parcel or lot of land in O'Neal Township, County of Greenville, State of South Carolina, being part of a 35.64 acre tract, plat of said tract being recorded in the RMC Office for Greenville County in Plat Book F at Page 513 and being shown as a 2.83 acre tract and having, according to a more recent survey by H. C. Clarkson, Jr., dated December 22, 1965, the following metes and bounds, to-wit:

Beginning at an iron pin in the center of S. C. Highway 93, said point being 947 feet northeast of the common corner of property of Alford, Fowler and Dill and running thence along the center of said S. C.
