All that lot of land in the County of Greenville, State of South Carolina, shown as lot 13 on plat of Sans Souci Park recorded in the R.M.C. office, for Greenville County in plat book "C", page 158 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Perry Road, at the corner of lot 14, which iron pin is situate 66 feet south of the intersection of McCall Street, and running thence S 58-54 W 210 feet to an iron pin; thence S 23-30 W 60 feet to an iron pin; thence N 58-54 W 210 feet to an iron pin on the eastern side of Perry Road; thence with said road N 29-30 E 60 feet to the point of beginning.

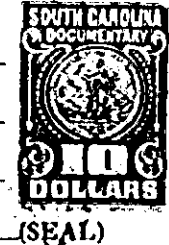
