In consideration of --- Four thousand five hundred and No/100 (\$4,500.00) ----- Dollars,

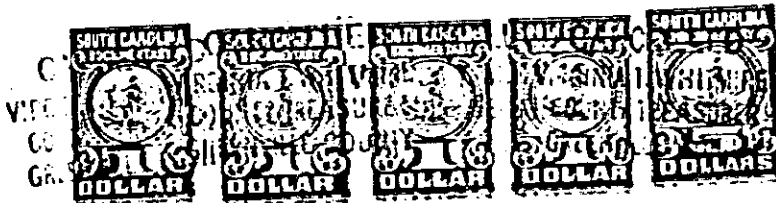
