ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, Grove Township, located on U. S. 25 (Augusta Road), approximately 10 miles south of Greenville, containing 1.77 acres according to plat prepared for Walter A. and Judy A. Green by Robert S.
