GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, Etta Emma Ward have constituted, made and appointed, and by these presents, do constitute, make and appoint Perry Alvin Ward true and lawful attorney for me and in my name and stead and to use my name and to ask, demand, sue for, levy and recover and receive all such sum or sums of money, debts, rents, goods, accounts, and other demands and real and personal property whatsoever, which are or shall be due, owing or payable to me or detained from me in any manner or ways or means whatsoever, including but not limited to the right and power to withdraw any and all savings accounts, bank accounts or full paid shares in any building and loan, savings and loan or bank and to buy or sell stocks and bonds.

GIVING AND GRANTING unto Perry Alvin Ward as my said attorney, by these presents, full and whole power, strength and authority in and about the premises, to have, use and take all lawful ways and means in my name for the recovery thereof; and upon the receipt of any such debts, dues, sums of money or real and personal property aforesaid to execute acquittances or other sufficient discharges for me and in my name to make, execute and deliver bills of sale and deeds of conveyance and generally to do any and every act or acts, thing or things needful and necessary to be done in my name as I might or could do if I personally were present, and particularly to look after, care for and manage any and all property now existing in my name or which will hereafter come into my name, including but not limited to the power and authority to withdraw any and all savings accounts, bank accounts, or full paid shares in any building and loan, savings and loan, or bank and to sell and transfer any shares of stock or bonds; it being the intent of this grant to clothe and empower the said Perry Alvin Ward with all authority necessary to act in my stead in connection with the carrying on or transaction of any business in which I might be interested and taking care of any business matters connected therewith.

Any and all persons shall have the right to rely upon this Power of Attorney until and unless the same is revoked in writing by me and the said revocation recorded in the R.M.C. Office for Greenville County, South Carolina, and this Power of Attorney shall not be revoked in the event of my incapacity for any cause.
