the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Dakota Christine S. Taylor, her heirs and assigns forever:

ALL that piece, parcel or tract of land, situate, lying and being in Butler Township, Greenville County, State of South Carolina, being known and designated as a portion of Lots Nos. 1, 2 and 3 on a plat of the C. P. Phillips Estate prepared by C. C. Jones, Engineer, dated April 1964, and recorded in the R.M.C. Office for Greenville County, S. C. in Plats Book FFF, at Page 151, and having, according to a more recent plat prepared for William T.
