Greene hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, Suzanne L. Greene, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, near Lake Mollirene shown on Plat of Carl C. Lanford, Sr. Estate, dated March 20, 1975, prepared by Carl C. Lanford, Professional Engineer, and recorded in Plat Book 58 at Page 9 in the R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a point on the southeast line of property of Carl C. Lanford, Sr., and running thence N. 23-35 E. 215 feet to a corner stone; thence turning and running N. 65-24 W. 57.5 feet to the center of a road running along the edge of said property; thence turning and running N. 80-04 W. 70 feet to a point in the center of said road; thence running N. 41-52 W. 140 feet to a point in the center of said road; thence running N. 55-17 W. 100 feet to a point in the center of said road; thence turning and running S. 1-19 W. 23 feet to a point on the edge of said road bounding said property; thence running S. 6-15 W. 258 feet to an iron pin; thence turning and running N. 85-45 W. 250 feet to an iron pin; thence turning and running S. 28-15 W. 110.0 feet plus or minus to a point, edge of property now or formerly of Suzanne L. Greene; thence turning and running S. 83-45 E. 540 feet to the point of beginning.
