ALL that piece, parcel or lot of land, situate, lying and being on the southern side of Roberta Drive near the City of Greenville, Greenville County, South Carolina, being known and designated as Lot 50, as shown on Plat No. 3, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, recorded in the RMC Office for Greenville County, S.
