And this power shall especially include the right to handle, care for, control, sell and dispose of any property, real or personal, that I may own, and to purchase for me any property, real or personal, and to execute deeds of conveyance.

The acts of the said attorney, which may be done under and by virtue of this instrument and the terms thereof, I ratify and confirm just as if I were personally present and executed and performed the said acts.
