the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mrs. Ethel F. McQueen and her heirs and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and being the southwestern portion (triangular in shape) of lot No. 1, or a subdivision of land of Mr. Goddett according to the plat made by Mr. Balten, recorded in plat book #, at page #, the portion herein conveyed having the following metes and bounds:

BEGINNING at a point 20 feet east of northern edge of Walnut Street, from the intersection of Walnut Street with Ailes, and running N. 72-1/2 W. 30 feet to the point of said intersection of Walnut Street with said Ailes; thence along the eastern edge of said Ailes N. 58-22 E. 40 feet to a point along line of lot No. 1, thence S. 16-50 W. 34 ft. 5 in. to the point of beginning.

The above is the property conveyed to H. F. Kerns and Zona Kerns by Mrs. Ethel F. McQueen and L. F. McQueen (L.F. McQueen has deceased). Also has my wife (Zona Kerns) the above property is part of property conveyed to Mrs. Janie Leslie by her deed dated July 18, 1957 same to be recorded in the R.M.C. Office for Greenville County. This is the same property conveyed by H. F. Kerns to Mrs. Ethel F. McQueen, her heirs and assigns by deed dated 10-10-1976.
