That John Drayton Hopkins and Julian Pelham Hopkins hereafter referred to as Grantors in consideration of the sum of Five Thousand, Nine Hundred Seventy-four & 25/100 (\$5,974.25) DOLLARS, paid to Grantor by Patricia Ann Coker hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, Patricia Ann Coker, her heirs and assigns forever:

ALL that certain piece, parcel or tract of land situate, lying and being in Oaklawn Township, Greenville County, South Carolina, containing 5.82 acres, more or less, and being shown and designated as Tract No. 3 on property of Nellie K. Hopkins Estate by Bakkum-DeLoach & Associates, dated October 5, 1976, and recorded in the Office of the R.M.C. for Greenville County in Plat Book 5 X at Page 31 & 32, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Alverson Road, joint front corner of Tracts 2 and 3, and running thence along the south side of Alverson Road, S. 74-21 E. 360.1 feet to an iron pin on the south side of Alverson Road, joint front corner of Tracts 3 and 4; thence along the line of Tract 4, S. 14-57 W. 636.58 feet to an iron pin, joint rear corner of Tracts 3 and 4; thence S. 85-06 W. 382.8 feet to an iron pin, joint rear corner of Tracts 2 and 3; thence along the line of Tract 2, N. 14-57 E. 770.94 feet to an iron pin on the south side of Alverson Road, the beginning corner.

Being a portion of the property owned by Nellie K. Hopkins, deceased, at the time of her death. The said Nellie K.
