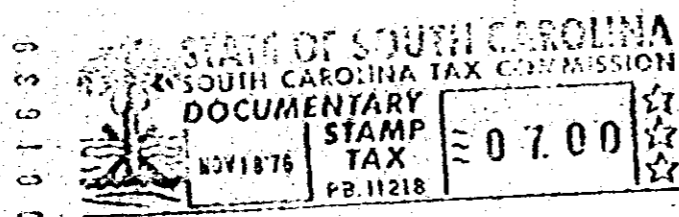
This conveyance is also made subject to any restrictive covenants, building setback lines and rights of way and easements which may affect the above described property.
