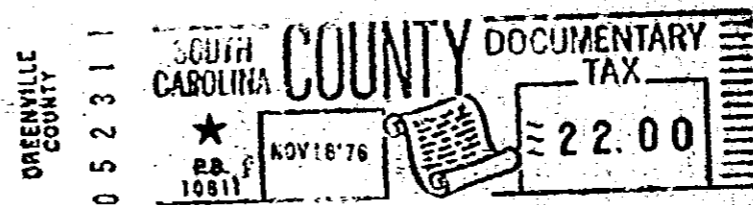
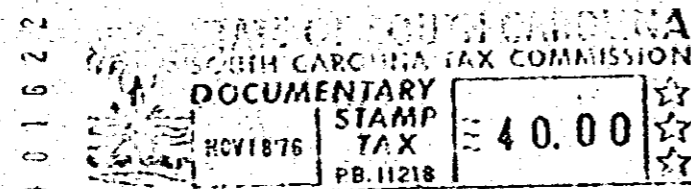
This conveyance is made subject to the restrictions applicable to Grand View Heights, recorded in Deed Book 577 at Page 403. - 366-494-1-44 NOTED
