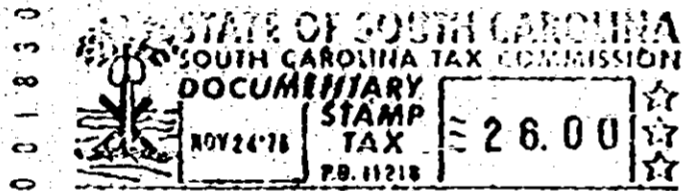
In consideration of Twelve Thousand, Seven Hundred, Fifty and No/100 (\$12,750.00) Dollars,
