ALL that certain piece, parcel or tract of land situate, lying and being in Oaklawn Township, Greenville County, South Carolina, containing 9.50 acres, more or less, and being shown and designated as Tract No. 6 on property of Nellie K. 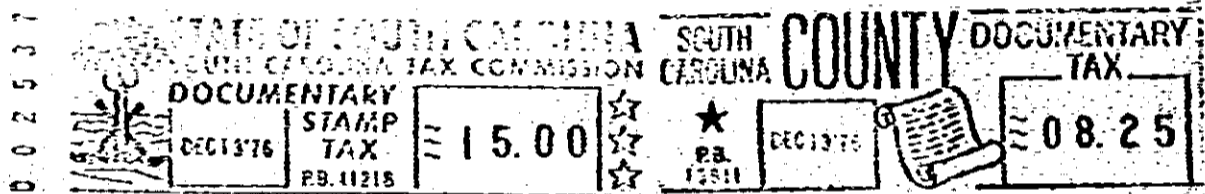
