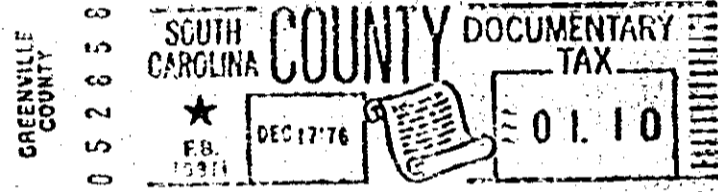
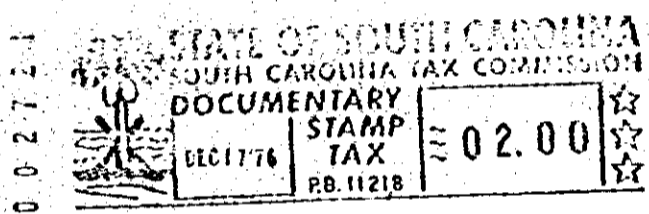
This conveyance is made subject to restrictions recorded in Book of Deeds 548 at Page 324.
