KNOW ALL MEN BY THESE PRESENTS:

That EASTERN DISTRIBUTION, INCORPORATED, a South Carolina corporation, Grantor, in consideration of the sum of THIRTY THOUSAND SEVEN HUNDRED SEVENTY-TWO DOLLARS (\$30,772) to it paid by the Grantee hereinafter named, receipt whereof is hereby acknowledged, and for other good and valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto SOUTHERN REGION INDUSTRIAL REALTY, INC., a Georgia corporation, Grantee, its successors and assigns.

ALL that certain tract or parcel of land situate, lying and being in Greenville County, South Carolina, and being more particularly described as follows: to wit,
