the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Naida H. Lyle, her heirs and assigns forever;

ALL that piece, parcel or lot of land, located, lying and being in the County of Greenville, State of South Carolina being shown and designated as Parcels 7-A and 8-A on plat entitled Property of Pauline J. Cornell, et al dated February 4, 1976, prepared by W. R. Williams, Jr. Engineer and having, according to said plat, the following metes and bounds, to-wit:

Tract 7-A

BEGINNING at a point on the western side of Brookside Drive at the joint front corner of Lots 5-A and 7-A and running thence N. 24-38 E., 120.0 feet to an iron pin; thence N. 17-11 E., 40.9 feet to an iron pin; thence S. 84-22 E., 63.6 feet to an iron pin on the northern side of Brookside Drive; thence with the curve of Brookside Drive S. 79-04 W., 40.5 feet to an iron pin, S. 45-57 W., 40.5 feet to an iron pin and S. 28-04 W., 120.2 feet to an iron pin, the joint front corner of Lots 7-A and 5-A, the point and place of beginning.

Tract 8-A

BEGINNING at an iron pin at or near a branch along a line of other property of the grantee herein and running thence N. 80-19 W., 374.1 feet to an iron pin; thence N. 29-48 E., 16.4 feet to an old iron pin in the line of property now or formerly of Odell; thence S. 80-59 E., 371.1 feet to an iron pin in or near a branch; thence S. 17-11 W., 19.8 feet to an iron pin, the point and place of beginning.
