Office for Greenville County in Plat Book F, Page 108, dated March 5, 1923, and recorded March 14, 1923, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the south side of Tallulah Drive at the joint front corner of Lot 7 and the rear corner of Lot 2 and running thence S. 25-40 W., 200 feet to a point at the rear of Lot 7 and the side of Lot 2; thence running N. 64-20 E., 77.4 feet to a point in the middle of Lot 7; thence running S. 25-40 W., 200 feet to the point on the southern side of Tallulah Drive; thence continuing along Tallulah Drive S. 64-20 W., 77.4 feet to the beginning point.
