Limited Partnership hereafter referred to as Grantor, in consideration of the sum of Twenty-seven thousand and no/100 (\$27,000.00) DOLLARS, paid to Grantor by E. Larry Kelley, Jr., hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his heirs and assigns forever:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 44, on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

Beginning at a point at the joint corner of Units 44 and 43 and thence running N 51-30 W 68.5 feet; thence turning and running N 38-30 E 21.1 feet; thence turning and running S 51-30 E 68.5 feet; thence turning and running S 38-30 W 21.1 feet to the point of Beginning.

This is a part of the property conveyed to the grantor by Carla A. Hills, Secretary of Housing and Urban Development by deed dated April 11, 1975, and recorded on April 14, 1975 in the R.M.C. Office for Greenville County in Deed Book 1016, at Page 729.
