By deed dated October 10, 1929 the Grantor conveyed Lot 45-L to R. R. Bishop and it subsequently developed that another party was also deeded Lot 45-L. Lot 64-L has been used by the Bishops for many years and is adjacent to Lot 45-L and it appears that no deed was ever issued by the Grantor for Lot 64-L and this deed is executed to correct this problem.

R. R. Bishop died testate leaving the Grantee as his widow and beneficiary.
