the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell
and release unto

Billy S. Bennett and Jane S. Bennett, their heirs and assigns forever;

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina,
situate, lying and being on the eastern side of Leyswood Drive near the City of Greenville
and being known and designated as Lot No. 15 on a plat of Section III of WADE HAMPTON
GARDENS Subdivision recorded in the RMC Office for Greenville County in Plat Book YY at
Page 179 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Leyswood Drive at the corner of Lot 14
and running thence with the line of said Lot, S.63-39 E. 165.3 feet to an iron pin; thence
S.44-52 W. 20 feet to an iron pin; thence S.05-13 E. 36.6 feet to an iron pin at the
corner of Lot 16; thence with the line of said Lot, N.89-43 W. 217.1 feet to an iron pin
on Colgate Drive; thence with the curve of the intersection of Leyswood Drive, the chord
of which is N.14-43 W. 55.5 feet to an iron pin; thence continuing with Leyswood Drive,
