All my right, title and interest in and to that certain piece, parcel, or lot
of land together with any improvements thereon situate lying and being in
the State of South Carolina, county of Greenville, lying and being at the
Southwestern corner of the intersection of Miller Street and Rebecca Street
(also known as Avenue A, Nicholtown Road) in the City of Greenville, County
of Greenville, State of South Carolina, being known and designated as Lot No.
1 as shown on a plat of property of W.N. Miller and E.E. Stone, prepared by
W.D. Neves, dated March 12, 1914, recorded in the R.M.C. Office for Greenville
County, South Carolina, in Plat Book J at page 255, and having according to
