the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell  
and release unto Ralph F. O'Sheilds, Sr. and Mary F. O'Sheilds and their heirs:

ALL that certain piece, parcel or lot of land, with all improvements  
thereon, or hereafter constructed thereon, situate, lying and being in  
the State of South Carolina, County of Greenville, in or near the city  
of Greer, and having the following metes and bounds:

an L-shaped lot corner of lot #5 on James Street and runs thence  
with James Street N. 45-30 W. 50 feet to an iron pin; thence with this  
street 10 feet to a corner of lot #4; thence with the line of this  
lot 218 feet to an alley; thence with the alley S. 45-30 E. 50 feet
