Township, said County and State, near the Spartanburg-Greenville County line, about one and
one half miles south east of the Town of Greer on the New Pelham Road, having the following
metes and bounds: Beginning at an iron pin on a branch near fork, of intersection with the
other branch, and runs thence N. 35 E 15-7 chs. to an iron pin in center of Greer-Pelham
