

SCHEDULE "A"

N 65-59 E 322.2 feet to an old iron pin; thence turning and running S 71-24 E 259.3 feet to an iron pin; thence turning and running N 24-46 E 79.9 feet to a point on the edge of Greenland Drive; thence turning and running S 46-07 E 21.6 feet to an iron pin; thence turning and running along the edge of Dera Street N 45-17 E 66.7 feet to an iron pin; thence turning and running S 60-06 E 190 feet to an iron pin; thence turning and running N 39-22 E 150.7 feet to an iron pin; thence turning and running N 87-0 E 448.4 feet to an iron pin; thence turning and running along line of property of Greenville Airport Commission, S 2-05 W 335.5 feet to an iron pin at the edge of the right-of-way of Century Road (Frontage Road); thence turning and running along the right-of-way of Century Road the following courses and distances: S 84-37 W 133.7 feet to a concrete marker; S 86-48 W 99.7 feet to a concrete marker; N 84-30 W 101.7 feet to a concrete marker; S 83-48 W 69 feet to an iron pin; S 83-48 W 231.1 feet to a concrete marker; S 72-23 W 102.2 feet to a concrete marker; S 84-01 W 241.9 feet to an iron pin; S 87-53 W 100 feet to an iron pin; N 74-37 W 100 feet to an old iron pin; N 52-50 W 115.9 feet to a concrete marker; N 41-07 W 152.3 feet to a concrete marker, the point of beginning.
