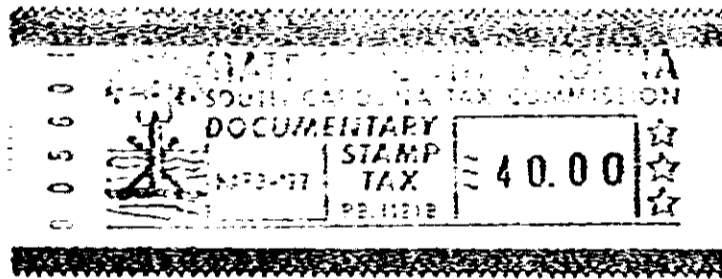

Being the same property conveyed by Evelyn E. Wilkins by deed recorded October 17, 1974 in Deed Book 1008 at page 693.

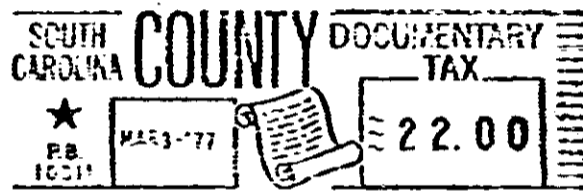
