WILSON B. RATLIFF, JR., his heirs and assigns, forever;

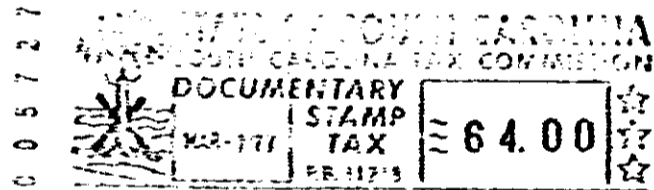
