Thomas B. Butler as shown per plat recorded in the R.M.C. Office for Greenville County at Plat Book QQQ, page 49, as a part of Tract D, and having the following metes and bounds:

BEGINNING at an iron pin at the intersections of the tracts known as Tract C and Tract D as shown per plat referred to hereinabove, S. 73-27 W. 917.88 feet to an iron pin; thence along with the boundary of the property of the Joseph Estate, N. 11-20 E. 971.00 feet to an iron pin; thence S. 86-40 E. 100.0 feet to an iron pin on the westerly side of a dirt road; thence S. 42-55 E. 797.0 feet along said dirt road to an iron pin; thence S. 24-42 E. 111.29 feet to the point of beginning.
