Plat for the above described property being in Plat Book 6 B at Page 3.

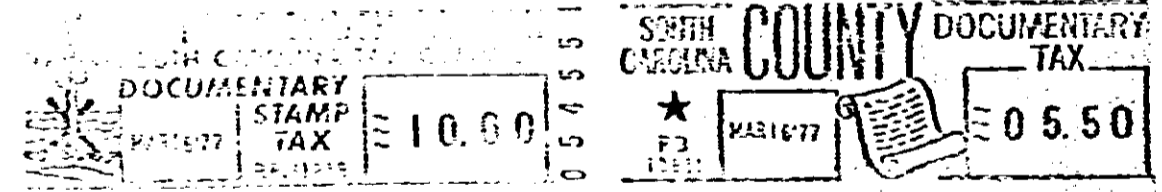
