ALL our right, title and interest in and to all that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of McDonald Street, in the City of Greenville, known as part of Lot 101 of North Hills, according to plat of North Hills, recorded in the R.
