NOW, THEREFORE, FOR AND IN CONSIDERATION of the sum of One and No/100 (\$1.00) Dollar and the premises herein, the undersigned do agree that the covenants applicable to Tugaloo Bluff, recorded in Deed Book 1045 at Page 50 shall apply to the additional tracts shown on the revised plat of Tugaloo Bluff, recorded in Plat Book 5-X at Page 70, the same being tracts consisting of 8.40 acres, 3.0 acres and 5.11 acres.
