POWER OF ATTORNEY

To the fullest extent permitted by law, my subsequent mental or physical incapacity shall not operate as a revocation of this POWER OF ATTORNEY.

If the authority contained herein shall be revoked or terminated by operation of law without notice, I hereby agree for myself, my executor, administrators, heirs and assigns, in consideration of my attorney's willingness to act pursuant to this POWER OF ATTORNEY, to save and hold my attorney harmless from any loss suffered or any liability incurred by my attorney in so acting after such revocation or termination without notice.
