

14. CLEARING OF QUARTERS. To effect the assignment or termination of U.S. Government quarters and to procure or return any and all U.S. Government property used in or for such quarters, and to execute all necessary documents, instruments, and papers therewith.

15. ADDITIONAL POWERS OR DELETIONS.

FURTHER, I do authorize my aforesaid attorney to perform all necessary acts in the execution of the aforesaid authorizations and generally to do any and all acts on my behalf in any other matter or thing pertaining or belonging to me with the same validity as I could effect if personally present.

AND I HEREBY DECLARE that any act or thing lawfully done hereunder by my said attorney shall be binding on myself and my heirs, legal and personal representatives, and assigns;

PROVIDED, however, that all business transacted hereunder for me or for my account shall be transacted in my name, and that all indorsements and instruments executed by my said attorney for the purpose of carrying out the foregoing powers shall contain my name, followed by that of my said attorney and the designation 'attorney-in-fact'

FURTHER, this power of attorney shall remain in full force and effect until the occurrence of the first of the following circumstances: (1) my death; (2) the death of my said attorney; (3) until the revocation of this power of attorney by me; or (4) until 1 January 1988

NOTWITHSTANDING my insertion of a specified expiration date of this power of attorney, IF on that specified expiration date or if at any time within the thirty (30) days immediately preceding that specified expiration date, I should be or have been carried in a military status of 'missing' or 'missing in action' or 'prisoner of war' THEN, this power of attorney shall automatically continue to remain valid and in full effect until sixty (60) days after my return to the continental United States or reassignment following termination of such 'missing,' 'missing in action' or 'prisoner of war' status.
