release unto **MICHAEL D. STROUD AND SHIRLEY C. STROUD, their heirs and assigns forever:**

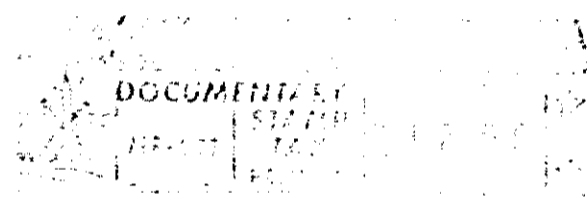
