said plat.

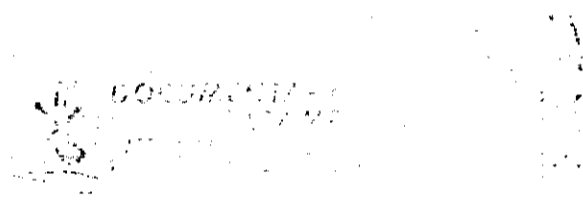
