Jordan, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, located on the eastern side of U. S Highway No. 29, and being known and designated as a portion of Tract No. 7 on plat of the Property of C. C. Good made by William Rast and recorded in the R. M. C. Office for Greenville County in Plat Book G, at Page 223, and having, according to a more recent survey prepared for T. H. Jordan by C. O. Riddle, Reg. L.
