In consideration of Eighteen Thousand, Nine Hundred, Ninety-three & 17/100 (\$18,993.17) Dollars, and assumption of mortgage referred to below, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto CHARLES DIPIETRO and ANNA DIPIETRO, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 161, Section I of a subdivision known as Merrifield Park and shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book 000 at Page 177 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corners of Lots Nos. 160 and 161 and running thence with the joint line of said Lots, S. 20-25 E. 200 feet to an iron pin, joint rear corner of Lots Nos. 160 and 161; thence with the line of Lot No. 163, N. 69-35 E. 110 feet to an iron pin, joint rear corner of Lots Nos. 161 and 163; thence with the line of Lot No. 162, N. 20-25 W. 200 feet to an iron pin in the right-of-way for Hudson Road, joint front corner of Lots Nos. 161 and 162; thence with the South side of Hudson Road, S. 69-35 W. 110 feet to the point of beginning.

ALSO: ALL that piece, parcel or triangular strip of land situate, lying and being on the southern side of Hudson Road being known and designated as a portion of Lot No. 162, Section I of Merrifield Park as shown on plat referred to above and having, according to a more recent plat prepared by Carolina Surveying Company, November 2, 1971, the following metes and bounds, to-wit:
