Know All Men by These Presents:

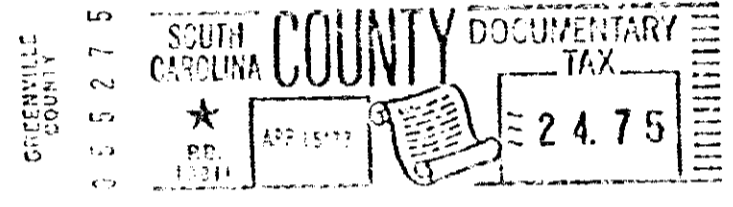

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 65 on plat of Harbor Town, recorded in the R.M.C. Beginning at a point at the joint corner of Units 65 and 64 and thence running N 38-39 E 20.8'; thence turning and running S 51-21 E 78.8'; thence turning and running S 38-39 W 20.8'; thence turning and running N 51-21 W 78.8' to the point of Beginning.
