KNOW ALL MEN BY THESE PRESENTS, that I, Martha G. Spillers,

in consideration of One Dollar and Correction of Deed-----Dollars.

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Carl L. Putnam, his Heirs and Assigns, forever:

All that piece, parcel, or lot of land with store building situate thereon, lying and being in the County and State aforesaid, Fairview Township, on the Neely Ferry Road, sometimes known as the Fairview Road, containing one (1) acre according to a plat and survey by C. O. Riddle, R.L.S., dated April 22, 1976, entitled "Property of Carl L. Putnam near Simpsonville, S. C.," and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of the Fairview Road, and running thence with the center of the Road N. 30-16 E. 136 feet to an iron pin in center of Road; thence leaving the Road, and running with the joint line of property belonging to David and Lynette V. Barbrey N. 62-45 W. 320.75 feet,

crossing an iron pin at 33 feet from center of road, to an iron pin on line of Barbrey, joint corner with other land of the Grantor; thence with joint line of other land of the Grantor S. 30-16 W. 136 feet to an iron pin; thence continuing with line of other land of the Grantor S. 62-45 E. 320.75 feet, to an iron pin in the center of the Fairview Road, crossing an iron pin at joint front corner with other land of the Grantor 33 feet from iron pin in center of the Road, the beginning point, and bounded by Fairview Road, Barbrey, and other land of the Grantor.

This deed is given to correct the description of original transfer recorded in said R.M.C. Office April 12, 1976, in Deed Volume 1034 at Page 536.
