All that certain piece, parcel or lot of land situate on the northern side of Wilderness Lane in the City of Greenville, Greenville County, State of South Carolina, being shown as portion of Lots Nos. 107 and 108 as shown on plat of Cleveland Forest recorded in the R.M.C. Office for Greenville County in Plat Book "M", Page 137 and having, according to a more recent survey made by R. E. Dalton the following metes and bounds, to wit:

Beginning at an iron pin on the northern side of Wilderness Lane, which pin is located 271.46 feet in an easterly direction from the corner of the intersection of Wilderness Lane and Dogwood Lane and running thence along the northern side of Wilderness Lane N72-16E 49 feet to pin in line of front line of Lot No. 107; thence N14-09W 160.2 feet to pin in line of Lot No. 124; thence along the rear line of Lot No. 124, S72-16W 40 feet to pin; thence with the rear line of Lot No. 123, N86-38W 31.1 feet to pin in rear line of Lot No. 108; thence S8-16E 172.3 feet to the point of beginning.
