
All that piece, parcel or lot of land in Saluda Township, Greenville County, South Carolina, containing 58 acres, more or less, situate on the northwestern side of Talley Bridge Road.

This is the remainder of 83 acres conveyed to J. Charlie Johnson by B. J. Johnson on October 22, 1940, in deed book 226, page 288. J. Charlie Johnson died intestate in 1961, leaving his widow, Minnie Jane Johnson and five children: Willie H. Johnson, Louise J. Hughes, John W. Johnson, Annie Marie Parnell and George Marshall Johnson. The interest of the widow was conveyed to the five children in deed book 1038, Page 198 on June 18, 1976, and interest of George Marshall Johnson, deceased, was conveyed to Jessie H. and Louise J. Hughes, Willie H. and Lillie B. Johnson by Jessie H. Hughes, et al on October 7, 1976, in deed book 1044 at Page 211.

This is the same property conveyed to the grantor herein by deed of Jessie H. Hughes, et al, dated October 29, 1976, and recorded in Deed Book 1049 at Page 188.
