RONALD T. WILLIAMS, his heirs and assigns forever:

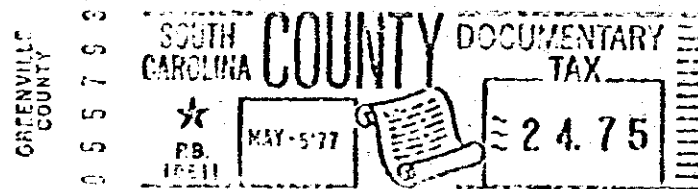
