(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
these presents do grant, bargain, sell and release unto the said Mildred Mease Harris  
her heirs and assigns:

all that piece, parcel or lot of land in Gantt Township, Greenville  
County, State of South Carolina, within the corporate limits of Greenville,  
South Carolina, being known and designated as Lot No. 373, accord-  
ing to plat of Pleasant Valley Subdivision, prepared by Dalton &  
Neves in April, 1946, as revised through September, 1950, as recorded  
in the R. M. C. Office for Greenville County, South Carolina, in Plat  
Book P, page 114, and having, according to said plat, the following  
metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Pacific Avenue at  
joint front corner of Lots Nos. 373 and 372; thence S. 0-08 E. 160  
feet to an iron pin at joint rear corner of Lots. Nos. 372 and 373;  
thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of  
Lots Nos. 373 and 374; thence along the joint line of said lots,  
N. 0-08 W. 160 feet to an iron pin on the Southern side of Pacific  
Avenue at joint front corner of Lots Nos. 373 and 374; thence along  
Pacific Avenue, S. 89-52 W. 60 feet to an iron pin at joint front  
corner of Lots Nos. 372 and 373, the point of beginning.
