Jones, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee his heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 97 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

Beginning at a point at the joint corner of Units 97 and 96 and thence running N71 - 30E 20.8'; thence turning and running S18 - 30E 68.7'; thence turning and running S71 - 30W 20.8'; thence turning and running N18 - 30W 68.7' to the point of Beginning. - 305 - B 2.4 - 1 - 97
