All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Rogers Avenue and being known and designated as Lot No. 5 and the western half of Lot No. 6 of Sans Souci Subdivision, as shown on a plat of Perry Property recorded in the RMC Office for Greenville County in Plat Book I at Page 33, and having the following metes and bounds, to-wit:

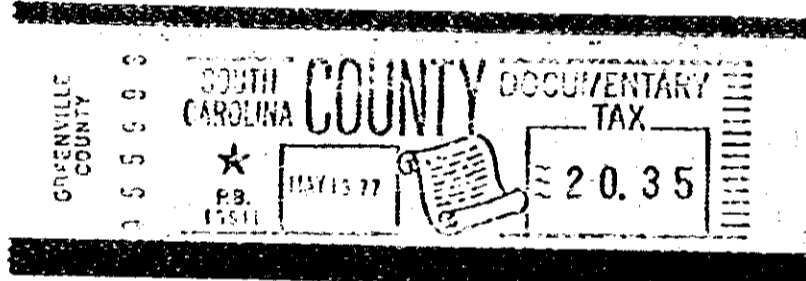
Beginning at an iron pin on the northern side of Rogers Avenue 200 feet east from Belmont Drive, the corner of Lot 4; thence with the line of said Lot, N.05-50 W. 150 feet to an iron pin, the corner of Lot 76; thence with the line of said Lot, N.83-55 E. 50 feet to an iron pin, the corner of Lot 75; thence with the line of said Lot, N.79-28 E. 19.5 feet to an iron pin; thence S.08-36 E. 150 feet to an iron pin on Rogers Avenue; thence with the northern side of Rogers Avenue, S.79-28 W. 25 feet to an iron pin; thence continuing with the northern side of Rogers Avenue, S.83-55 W. 50 feet to the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights-of-way appearing on the property and/or of record.
