in consideration of --Thirty-Six Thousand and No/100 (\$36,000.00)-----Dollars,

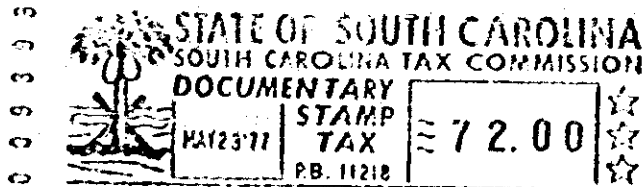
